Sim pib qhib yog lub Kaum Ib Hlis Ntuj Hnub tim 2, 2020 Txawm koj swm siv electronic visit verification (kev txheeb thaum sib ntsib hauv tshuab hluav taws xob) (EVV) rau hauv koj lub neej txhua hnub lawm los, peb xav qhia ntxiv txog EW ua hauj lwm li cas nrog tshuab hluav taws xob, xws li kev pov thawj EVV thiab kev khiav qhov app nruab hauv tshuab nqa ntawm tes.

## Raws Li Kev Paub Zoo

Peb paub tias EVV yog ib txoj kev siv tshuab tshiab kom swm. Nram no peb muab cov qauv ua piv txwv txog qee cov ua yuam kev uas peb hnov txog qhov txheej txeem Sandata EVV thiab cov ncauj lus kho kom yog.

- 1. Tsis Muaj Tseeb:** EVV taug qab cov neeg ua hauj lwm thaum lub sij hawm sib ntsib thiab thaum twg lawv tsis txuas npe nkag.  
**Muaj Tseeb:** Sandata qhov app nruab hauv tshuab nqa ntawm tes tsuas sau cov ncauj lus tseg thaum tus neeg ua hauj lwm txheeb npe tuaj thiab txheeb npe tawm thaum pib thiab thaum xaus lawv lub caij ua hauj lwm. Yog cia lub tshuab nyob tsis kov mus txog tsib feeb, qhov app yuav cia li kaw tseg. Nws tsuas nthos tau qhov chaw thaum lub sij hawm kiag tus neeg ua hauj lwm txheeb npe tuaj thiab nthos dua lub sij hawm kiag thaum tus neeg ua hauj lwm txheeb npe tawm xwb.
- 2. Tsis Muaj Tseeb:** Yog lwm lub chaw muab EVV muaj pov thawj siv tau rau hauv lwm lub xeev, lub chaw muaj pov thawj kav Wisconsin, thiab.  
**Muaj Tseeb:** Txawm yog lub chaw lis tiav kev pov thawj rau Sandata ntawm lwm lub xeev los lawv yeej tseem yuav tsum tau muaj kev pov thawj siv tau hauv Wisconsin. Kawm ntxiv txog qhov txheej txeem lis kev pov thawj rau Lwm Qhov Chaw Muab EVV ntawm [DHS Alternate EVV \(Lwm Qhov Chaw Muab EVV\)](#) qhov vas sab.

Tsab ntawv xov xwm no yuav qhia cov ncauj lus txog EVV hauv Wisconsin. Xya Hli Ntuj 2020 ForwardHealth Tsab Ntawv Tshiab 2020-31, tis muaj npe hu ua "[Kev Siv Electronic Visit Verification for Personal Care and Supportive Home Care Services \(Txoj Kev Siv Electronic Visit Verification rau Cov Kev Tu Xyuas Neeg thiab Kev Pab Txhawb Hauv Tsev\)](#)," muaj cov lus koj qhia uas pom zoo.

(Txuas ntxiv rau nplooj dhau los.)

- 3. Tsis Muaj Tseeb:** EVV yuav txwv tsis muaj kev tu xyuas neeg tau kev pab.

**Muaj Tseeb:** Yog tias ib tug neeg tau kev pab yuav tsum tau muaj kev tu xyuas tam sis, qhov ntawd yog qhov tseem ceeb ua ntej. Yuav tsum muaj kev kho mob kub ceev ua ntej kev txheeb npe tuaj rau hauv EVV.

- 4. Tsis Muaj Tseeb:** Cov neeg ua hauj lwm yuav tau txheeb nep tuaj thiab txheeb npe tawm rau txhua txoj luag num thawm lawv lub sij hawm sib ntsib.

**Muaj Tseeb:** Cov neeg ua hauj lwm siv tib tug zauv cim kev pab txheeb npe tuaj thiab txheeb npe tawm (kev tu xyuas tib neeg, kev pab txhawb tu xyuas hauv tsev) uas duav tau ntau ntau yam hauj lwm. Yog ib lub chaw muab kev pab xav tau, lawv yeej hais tau kom cov neeg ua hauj lwm ceeb toom qhia tej luag num tshwj xeeb kiag (piv txwv, kev pab hnav khaub ncaws, kev pab mus tso zis tso quav, los sis txav chaw) thaum qhov txheeb txhee txheeb npe tawm. Cov neeg ua hauj lwm xaiv cov tes luam num ntawm cov teev muaj thaum lawv txheeb npe tawm, thiab tsis tag teev qhia sij hawm siv ntev li cas rau ib hom tes luag num twg.

- 5. Tsis Muaj Tseeb:** Yuav tsum tau muaj xaim Wi-Fi los sis xaim xov tooj ntawm tes nyob rau hauv tus tswv cuab los sis neeg koom kev pab lub tsev thiaj li siv tau EVV.

**Muaj Tseeb:** Tag nrho peb hom EVV (mobile visit verification (kev txheeb npe hauv tshuab nqa ntawm tes thaum sib ntsib) [MVV], telephonic visit verification (kev txheeb npe hauv xov tooj thaum sib ntsib) [TVV], los sis fixed visit verification (kev txheeb npe hauv tshuab nruab ruaj) [FVV]) tsis tag yuav tsum muaj xaim Wi-Fi los sis xaim xov tooj ntawm tes rau thaum lub sij hawm muaj kev sib ntsib. Yog koj tsis muaj xaim Wi-Fi los sis xaim xov tooj ntawm tes nyob rau hauv tus tswv cuab los sis neeg koom kev pab lub tsev, koj yuav pib kev sib ntsib tau hauv Sandata Mobile Connect (SMC) qhov app. Yog koj tsis muaj xaim txuas, yuav muab qhov kev sib ntsib no nraim tiv thaiv thiab nthos uas “kev sib ntsib nrog tus neeg tsis paub.” Thaum twg sib ntsib tiav, lwm zaus koj qhib qhov app ntawm qhov chaw muaj xaim Wi-Fi los sis xaim xov tooj ntawm tes, qhov app yuav ceeb toom cov ncauj lus txog qhov kev sib ntsib rau hauv qhov txheeb txheem Sandata. Txij li ntawd mus, tus neeg tuav hauj lwm lis ntaub ntawv hauv koj lub koom haum muab kev pab yuav muab qhov “kev sib ntsib nrog tus neeg tsis paub” kho kom txuam nrog tus neeg tau kev pab uas yog.

Yog tsis muaj koj qhov app SMC, koj puav leej siv tau tus neeg koom kev pab lub xov tooj txuas xov hauv tsev los sis Voice over Internet Protocol (Nruab Hais Suab Lus Hauv Iv Taws Nej) hu mus rau EVV (uas yog siv telephonic visit verification (kev txheeb npe hauv xov tooj thaum sib ntsib)). Yog tias koj siv tsis tau SMC qhov **thiab** tus tswv cuab los sis neeg koom kev pab tsis muaj lub xov tooj txuas xov hauv tsev los sis Voice over Internet Protocol (Nruab Hais Suab Lus Hauv Iv Taws Nej) rau koj siv tau, koj lub koom haum thov tau lub tshuab siv fixed visit verification (kev txheeb npe hauv lub tshuab nruab ruaj) rau lawv. Tsis tag yuav muaj xaim iv taws nej thiaj siv tau telephonic visit verification (kev txheeb npe hauv xov tooj thaum sib ntsib) los sis fixed visit verification (kev txheeb npe hauv lub tshuab nruab ruaj).
