

Tsab ntawv xov xwm no yuav qhia cov ncauj lus txog EVV hauv Wisconsin. Xya Hli Ntuj 2020 ForwardHealth Tsab Ntawv Tshiab 2020-31, tis muaj npe hu ua "[Kev Siv Electronic Visit Verification for Personal Care and Supportive Home Care Services \(Txoj Kev Siv Electronic Visit Verification rau Cov Kev Tu Xyuas Neeg thiab Kev Pab Txhawb Hauv Tsev\)](#)," muaj cov lus coj qhia uas pom zoo.

Nyob zoo! Lub xyoo tas los no cov nyom heev rau peb ntau leej ntau tus. Peb xav muab lub sij hawm no los ua koj tsaug rau koj txoj kev peem dhau ntau cov kev nyuab ntxhov hauv xyoo 2020 kom pab tau cov tswv cuab, cov neeg koom kev pab thiab cov tsev neeg hauv Wisconsin.

Nyob rau hauv tsab ntawv no, peb yuav qhia txog kev xyaum siv electronic visit verification (kev txheeb npe hauv tshuab hluav taws xob thaum sib ntsib) (EVV) thiab nws txhais li cas rau peb hauv Wisconsin. Peb yuav sau txog cov ncauj lus uas Wisconsin Department of Health Services (Tuam Tsev Tswj Xyuas Cov Kev Kho Kab Mob Kev Nkeeg) (DHS) soj xyuas thiab cov koom haum muab kev pab taug qab tau lawv txoj kev siv EVV vam meej li cas.

## Vim Yog Koj Nug Txog!

**Q:** Vim li cas Wisconsin thiaj txwv kom siv EVV tam sim no? Ncua nws puas tau?

**A:** EVV yog tsoom fwv teb chaws txoj kev yuam. Qhov ntawd txhais tau tias yog lub xeev tseem tsis tau siv EVV thaum txog lub Ib Hlis Ntuj Hnub tim 1, 2021, nws yuav plam cov nyiaj txiag pab. Tsuas yog fab nom tswv Congress thiaj li ncua tau hnub kawg rau siv no, thiab lawv tseem tsis tau ncua nws.

**Q:** Cov kev txwv txiav txog EVV hauv Wisconsin yog dab tsi?

**A:** Tag nrho cov kev tu xyuas neeg thiab qee cov kev pab tu xyuas hauv tsev (cov zauv cim kev tu xyuas T1019, T1020, S5125, thiab S5126) yuav tsum muaj EVV. Tam sim no, Wisconsin tseem pab cov neeg ua hauj lwm thiab cov koom haum muab kev pab xyaum kom siv qhov txheej txhem EVV tshiab ua ntej yuav pib tsis kam them cov nqi rau txoj kev tsis muaj cov ntaub ntawv EVV txhij.

Kom ib qho kev sib ntsib hauv EVV phim rau ib daim nqi, nws yuav tsum nthos tau 6 qhov ncauj lus tseem ceeb: leej twg tau qhov kev tu xyuas, leej twg muab qhov kev tu xyuas, muab yam kev tu xyuas twg, muab qhov kev tu xyuas nyob rau qhov twg, hnub muab qhov kev tu xyuas thiab lub sij hawm tuaj txog/tawm. Kom nthos tau cov

(Tsuas ntxiv rau nplooj tom ntej.)

ncauj lus no, cov koom haum muab kev pab siv tau lawv qhov txheej txheem Sandata EVV uas yog muab los ntawm DHS, los sis lwm qhov txheej txheem siv nrog Sandata aggregator. Yog cov koom haum muab kev pab siv lwm qhov txheej txheem, lawv yuav tsum tau ntawv pov thawj los ntawm Sandata thiab DHS ua ntej yuav siv tau.

**Q:** DHS puas taug qab leej twg siv EVV?

**A:** Taug qab. DHS yuav kom cov koom haum muab kev pab teeb muaj cov kev siv EVV ruaj chaws ua ntej yuav pib qhib, vim thaum twg cov ntawv sau nqi tsis muaj txhij cov ncauj lus hauj EVV ces yuav raug tsis kam them rau. Peb xav muab lub caij no los pab daws kho tej teeb meem uas tshwm sim muaj, kom txhua tus siv tau EVV ua ib feem ntawm lawv qhov txheej txeeem khiav hauj lwm txhua hnub.

DHS xav txhawb kom cov koom haum muab kev pab nrog soj qab xyuas lawv cov ntaub ntawv kom lawv paub tias lawv cov neeg ua hauj lwm siv EVV tau zoo npaum li cas.

**Q:** Cov koom haum muab kev pab yuav ua li cas thiab txhim kho tau lawv txoj kev siv EVV kom zoo dua ntxiv?

**A:** DHS yeej nkag siab tias txoj kev ua hauj lwm nrog ib yam txheej txheem tshiab yuav cov nyom thiab peb yuav muab sij hawm rau koj txheeb nrhiav kom paub tias yam twg ua hauj lwm thiab yam tsis ua hauj lwm rau koj lub koom haum muab kev pab yog dab tsi. Yog tias koj daws tau koj cov teeb meem ntawm EVV tam sim no, koj yuav cheem tau kev coj tsis zoo ua ntej lawv rais los ua cov cuj pwm tsis zoo—thiab yuav txuag tau koj cov sij hawm tseem ceeb!

Rau cov koom haum muab kev pab uas siv Sandata, qhov txheej txheem uas DHS-muab, Sandata EVV Portal (Chaw Muab Kev Pab Saum Huab Cua) yuav kheev cov koom haum muab kev txheeb cov ntawv ceeb toom raws tus neeg ua hauj lwm npe, tus neeg tau kev pab los sis raws hom kev seem tseg.

Muaj Sandata EVV Online Manual (Phau Ntawv Qhia Siv Saum Huab Cuab) rau cov neeg tuav hauj lwm lis ntaub ntawv nyob rau ntawm Sandata EVV Portal (Chaw Muab Kev Pab Saum Huab Cua). Ntu Reports (Cov Ntawv Ceeb Toom) teev muaj cov ntsiab lus qhia xyuas cov ntaub ntawv nthuav txog cov kev sib ntsib. Qhov “Detail Visit Status Report” (Ntsiab Lus Ceeb Toom Txog Kev Sib Ntsib) yog ib qho chaw zoo pib xyuas heev. Qhov no xyuas ua ke cov pawg tswv cuab/neeg koom kev pab thiab neeg ua hauj lwm kom tshwm cov kev seem tseg, cov kev tu xyuas, cov hnub, cov caij nyoog, thiab cov kev kho rau cov sij hawm hu tuaj txheeb npe thiab hu tawm txheeb npe nyob rau hauv ib tsab ntawv ceeb toom.

Rau cov koom haum uas siv lwm qhov txheej txheem EVV, Sandata aggregator portal (chaw muab kev pab saum huab cua) yuav keev cov koom haum muab kev pab siv lwm qhov txheej txheem EVV los rub cov ntawv ceeb toom zoo sib xws, nrog rau Detail Visit Status Report (Ntsiab Lus Ceeb Toom Txog Kev Sib Ntsib).

Kev lis cov ntawv ceeb toom yog ib txoj kev taug qab zoo heev txog cov neeg ua hauj lwm txoj kev siv EVV zoo npaum li cas thiab ntev mus yuav pom tias nws khiav hauj lwm zoo li cas! Piv txwv, yog tus neeg ua hauj lwm tau muaj ntau cov kev sib ntsib nrog “tus neeg

tau kev pab tsis paub”, tej zaum lawv yuav tsum tau muaj kev pab txhawb thiab kev kawm ntxiv txog kev pib ib qho kev sib ntsib. Thaum paub txog tej yam teeb meem uas cov neeg ua hauj lwm ntsib muaj thiab pab lawv daws tau cov teeb meem ntawd, koj yuav txuag tau koj lub sij hawm thiab lub dag zos lis ntaub ntawv (vim tsis tau yuav xuas tes kho dua cov kev sib ntsib) nrog rau txoj kev txhim kho koj txoj kev siv EVV tag nrho.



## Pom Zoo Rau Kev Nyeem

Peb tau qhia ob peb qho chaw txuas mus cuag cov kev pab uas cov koom haum muab kev pab thiab cov neeg ua hauj lwm yuav pom tias pab tau kom EVV yog ib feem npiliag lias hauv txoj kev sib ntsib txhua zaus.

Cov koom haum muab kev pab yuav tsum tso siab lug muab tej kev pab no qhia rau lawv cov neeg ua hauj lwm.
- Cov neeg ua hauj lwm thiab cov koom haum muab kev pab uas yog fee-for-service (kev-them-nqi-rau-kev-pab) yuav nrhiav tau cov ncauj lus tshiab tshaj plaws txog EVV hauv ForwardHealth Online Handbook (Phau Ntawv Qhia Saum Huab Cua) nram qab Electronic Visit Verification (Kev Txheeb Npe Hauv Tshuab Hluav Taws Xob Thaum Sib Ntsib) ntawm ntu Personal Care service (Kev Pab Tu Xyuas Tib Neeg).

Zoo li txhua zaus, cov koom haum muab kev pab uas muab cov kev pab ntawm lub managed care organization (koom haum tswj kev tu xyuas), HMO, los sis fiscal employer agency (koom haum tuav nyiaj txiag) yuav tsum tau txheeb nrog lub chaw them ntawd kom paub ntxiv txog kev coj thiab cov chaw muab kev pab.
