

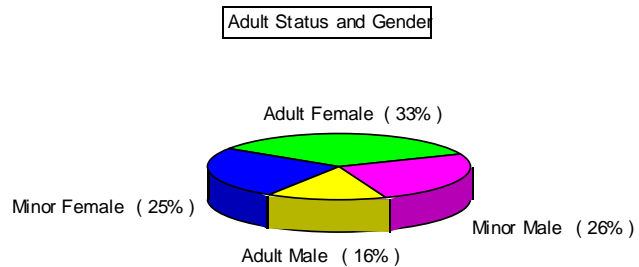
# FoodShare Wisconsin Program at a Glance

## Who receives FoodShare Benefits in Wisconsin?

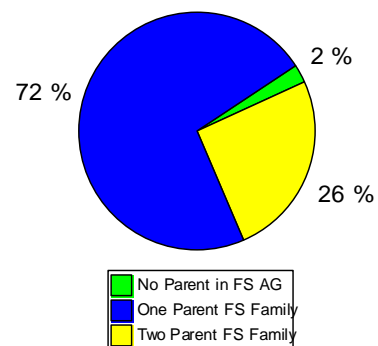
- **Poverty:** 7% of the 5.6 million people in Wisconsin receive FS.<sup>2</sup> On average from 1998 - 2000, 8.8% of the state population was at or below the federal poverty rate.<sup>3</sup>
- **Assistance Groups (AG's)/Individuals:** 168,432 Assistance Groups are made up of 394,348 individuals. The AG's count increased by 1,660 from the Previous Month. There is an average of 2.4 people in an AG.

- **Gender:** 58% of the recipients are female and 42% are male.



- **Adults/Minors:** 49% are adults while 52% are minors. 56% of AG's have minors in them.

- **Minors and Their Parents:** Of the AG's that contain minors, 72% have one parent in the AG, 26% have two parents, and 2% have no parents in the household. "Parent" is defined as a biological or adoptive parent.



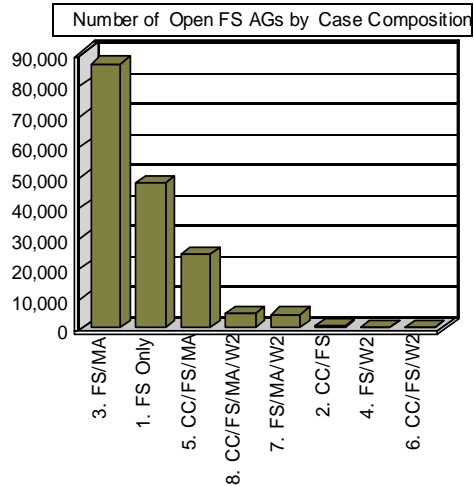

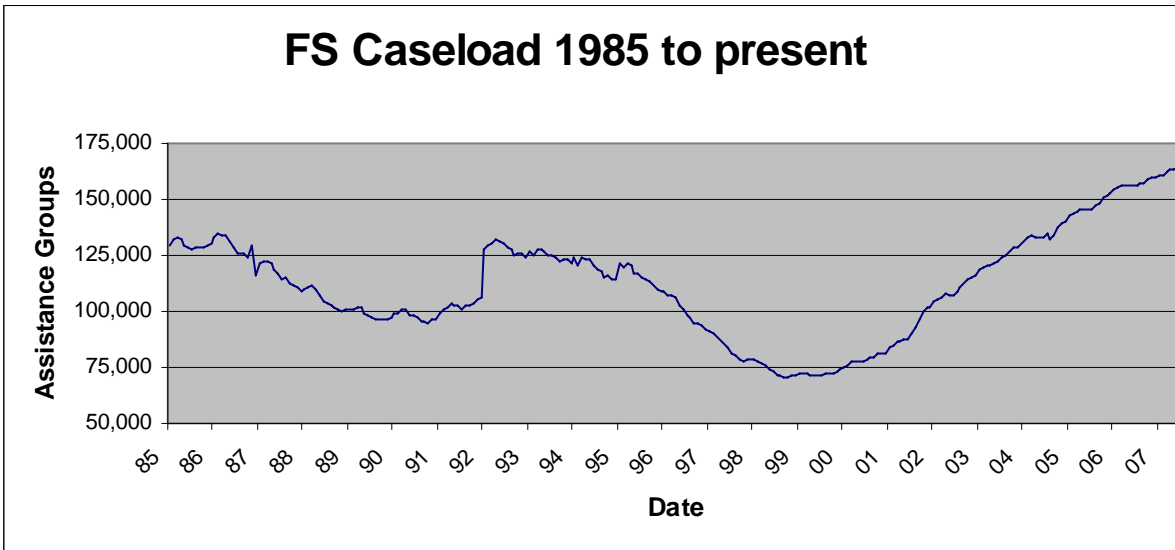

- Parents That Are Minors:** There are 1,008 minors in 989 FS AG's that are parents. A slightly lower number than last month and comprises 1/3 of 1 percent of the individuals that receive FS.
- Case Composition:** The table and graph shows other types of CARES issued assistance that a FS AG receives.

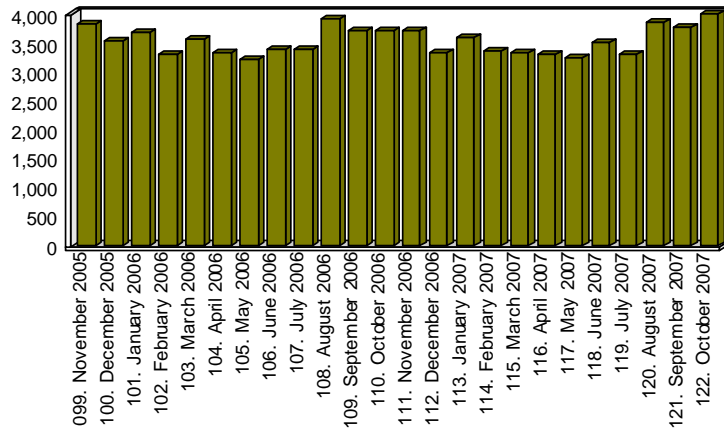

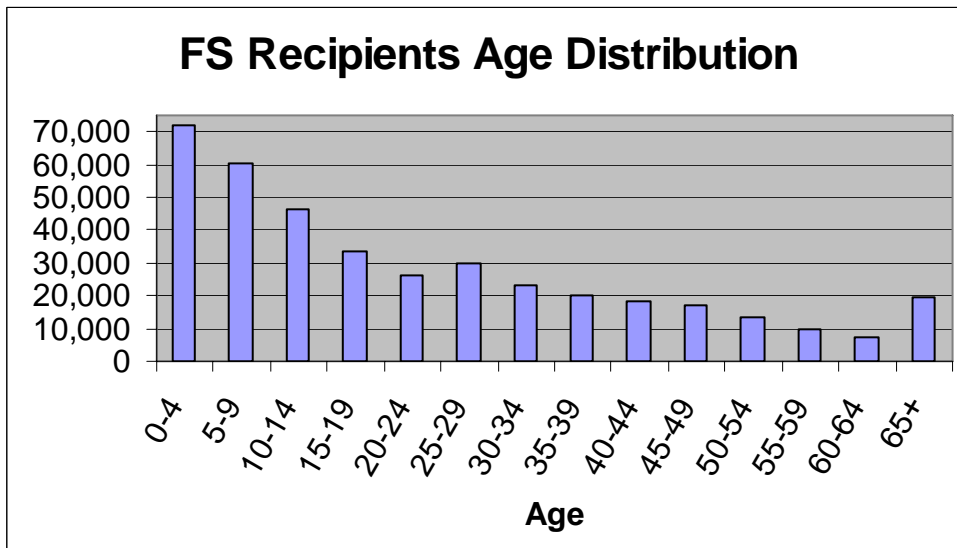
- Historical Caseload Trend:** The statewide caseload is slightly higher from last month contributing to a 6.2% increase over 12 months.



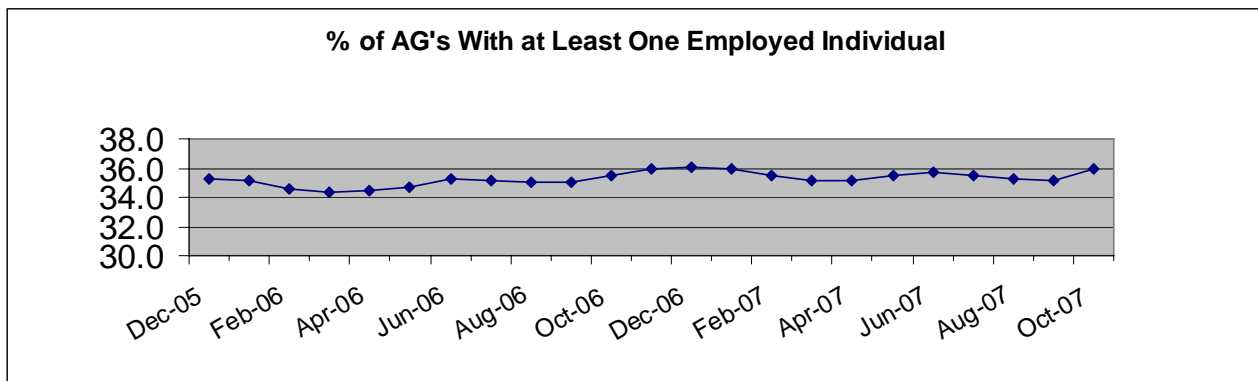
- First Time FS AG's:** This chart shows the number of first-time FS assistance groups over the last 2 years. Only AG's that have never received FS in Wisconsin before the month shown, appear in this chart. In October, 3,997 FS AG's received FS for the first time.



- Age Distribution:** The chart below shows the number of FS recipients by age, in 5 year increments. Children age 4 and under have the largest number for any five year grouping making up 18% of recipients. Half of the recipients are 17 and younger.



- **Elderly/Disabled:** 17.9% of FS recipients are elderly, blind, or disabled. 40% of AG's contain at least one individual that is elderly, blind, or disabled. The average allotment for AG's that contain an elderly, blind, or disabled member is at \$117. However, 33% of the EBD caseload is receiving an allotment of \$10 or less.
- **Work/Earnings:** 36% of the AG's have at least one person working. The average monthly earned income of those AG's' is \$1,112,<sup>4</sup> a \$9 increase from last month. 39% of adult FS recipients are employed, higher than last month. Currently, the seasonally adjusted unemployment rate in Wisconsin is 5.2%, the same as last month.<sup>5</sup>



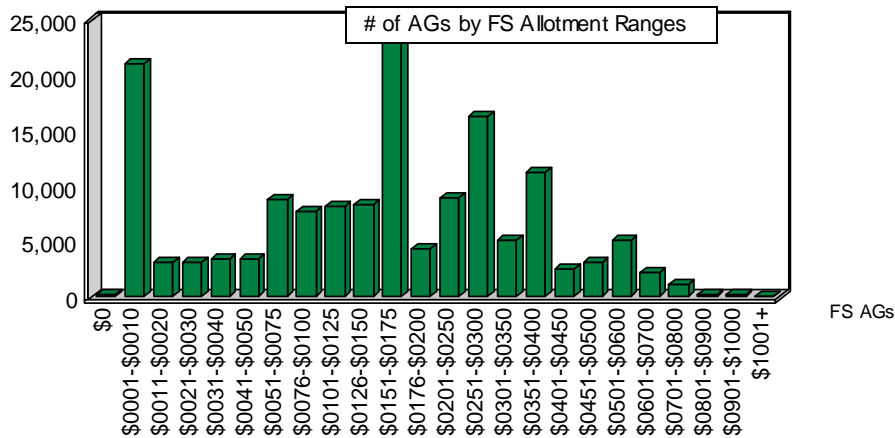
- **Working Families:** A "working family" is defined as a FS AG that contains at least one minor, at least one parent of a minor, and at least one employed recipient. This is an attempt to explore those FS recipients that have children and are working. Working families make up 28.4% of the statewide FS AG's, average 3.6 persons per AG, and average \$1,242 in earned income per month. Other stats are available below.

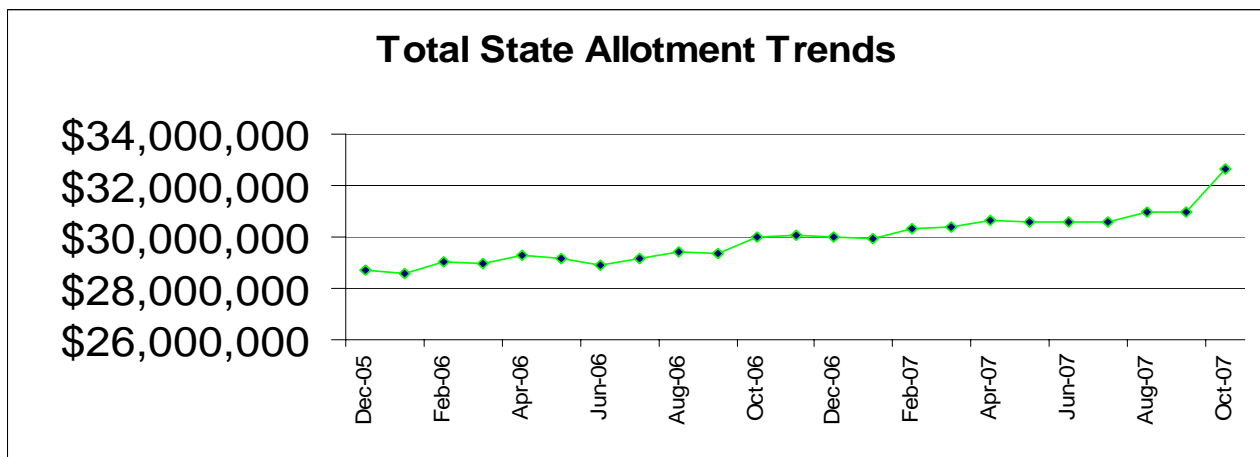

- **Allotments:** A total of \$32.6 million in food stamp benefits were allotted for the month. The average allotment amount per AG is \$194.



- **Statewide FS Allotments:** The graph below shows the total dollars in FS allotments spent on all FS AG's statewide for the past two years. Total issuance for this month stands at \$32.6 million. The October increase is a result of the annual cost of living increase.
