 This is a provider / joint provider assessment, but there is a separate system that collects data on County/Tribe performance and participant and family satisfaction, captures consumer voice

Emma McGovern – Ethnicity based care, LQBTQIA+ and quality of care

- This data is focused on who is being served, there is no reference and ability to collect quality of care. The data system will not impact local practice. Currently there is no sexual orientation collected, but will incorporate into new system

Kathryn Kosmaule – Are there indicators that identify dual enrolled youth?

- In the new system this will be enhanced and will include additional programs and services. Any program/system that a youth is involved in that is not a behavioral health system then this would not be included in this new system
- Another source of data collected is the Annual Survey by program (CST, CCS, ect.)

John Bauman – has there been any discussion on integrating other data collection systems?

- There has not been discussion, due to authority of DCTS

Phil Robinson – will there be the ability to review past data?

- This information has not been identified, as this is a system design. DCTS will have the ability to store historical data

Rob Kaminski – is there a requirement for CST Coordinating Committee meetings, similar to the CCS Coordination Committee Meetings?
