Council Member Updates and Announcements

Public Comments

- Overview of the Data Breach with CLTS Data
 - Both the county and the Wisconsin Department of Health Services (DHS) communicated to all CLTS participants that were potentially impacted by the 2021 PowerPoint that contained a link to participantlevel information
 - o Ongoing security monitoring services were offered to families
 - o DHS has taken additional remediation efforts to prevent future potential data breaches

Children's Community Options Program (CCOP) Data: Follow Up

- Overview of CCOP Program
 - o CCOP is a funding option of last resort
 - Reviewed categories of services included in CCOP
- Access
 - o Provided overview of enrollment by county
 - o Total enrollment for 2021 was 4,330
- Utilization Data

- Percentage of funds spent in CCOP categories
 - Recreational services and items, 56%
 - Adaptive Aids account, 18%
 - Assessment, Plans, and Case Management, 15%
 - In-home Supports, 6%

2023-2025 Biennial Budget Inputs

- CLTS Wisconsin County Human Service Association (WCHSA) Biennial Budget Paper
 - o WCHSA is proposing eliminate county MOE that can potentially make CCOP funds more equitable
 - Eliminate MOE requirement by providing additional GPR to buy out the county MOE portion
 - Provide additional funding for CCOP based on the number of children with disabilities so counties have a more equitable amount of CCOP funds
 - This proposal may be one of the WCHSA final budget proposals to the Governor's budget.
- Council Budget Paper, 2022-2024 Biennial Budget Recommendations
 - o Permanent funding for all eligible children
 - o Establish a statewide Disability Resource Center for Children and Families
 - Address the Workforce Crisis
 - o Medicaid Policy-HealthCheck Other Services, increase access to this service/benefit

Final Parental Payment Limit (PPL) Memo and Materials

- o The Bureau of Children's Services (BCS) initiated PPL project to standardize PPL across all county waiver agencies (CWAs)
- o PPL policy changes go into effect in 2023
- o Key policy changes
 - Standard disability allowance has been increased from \$3,300 to \$4,050 per child with a disability
 - CWAs may bill PPL based on the cost of actual claimed services or use planned costs if reconciled with actual claimed costs
 - Families do not have to provide tax documents, pay stubs, or W-2 documents to verify their income or expenses for PPL determination
 - Recalculations must occur when in the best interest of the family or if there are significant changes with the Individual Service Plan (ISP)
 - New guidance given to CWAs on how to determine a financial hardship
- PPL Family Communications
 - o PPL Fact Sheet is scheduled to be available in December 2022
 - Simplifies policy changes for families and informs them of how much they will have to pay, services they will pay for, documents needed
 - o Family Feedback Discussion by Council Members
 - Consideration around families that do not have traditional type income (e.g., business owners, etc.)
 - Billing considerations for families to anticipate costs
