- Roberto Escamilla II commented that he read an article about proposed housing legislation that could impact people with disabilities in WI.

VI. Presentation by Representative Jimmy Anderson on His Authored/Sponsored Proposals and Legislation That May Impact People with Disabilities in WI

- Representative Jimmy Anderson and Chris Stoa discussed the following Legislation:
 - Assembly Bill 904/Senate Bill 831 relating to information technology accessibility standards and rule-making authority. Representative Jimmy Anderson explained that he would like to see all state websites be accessible and he said he is interested in learning more about the Title II changes to the Americans with Disabilities Act (ADA).
 - Assembly Bill 785 requiring hospitals to provide plain language itemized billing. Representative Jimmy Anderson stated that constituents have reached out to his office expressing distress about confusing medical bills. Representative Jimmy Anderson discussed the need for plain language with members.

- CPD Members, Representative Jimmy Anderson and Chris Stoa discussed ways CPD can work with the Representative's office to remain informed on issues concerning individuals with physical disabilities in WI.

IX. CPD Liaison Updates

- Sarah Smith, Wisconsin Office of the Commissioner of Insurance (OCI)

- OCI is preparing for Open Enrollment and continue to support the Medicaid unwinding post pandemic efforts to maintain health coverage for Wisconsinites. - **Taqwanya Smith, Wisconsin Department of Transportation**
 - Public Comment was received for the 2023 ADA Transition Plan. DOT is reviewing comments. DOT is partnering with the Office for Deaf and Hard of Hearing (ODHH) and Independence First to provide information in ASL.
- **Eva Kubinski, Wisconsin Department of Public Instruction:**
 - No report received.
- **Kristine Zuckrow, Wisconsin Department of Workforce Development:**
 - DVR is seeing an increase in referrals and applicants. Kristine Zuchrow shared quarterly reports on Consumers with physical disabilities receiving benefits counseling, rehabilitation technical services and training grants. DHS Support Staff shared reports via email with CPD prior to meeting. Kristine shared DWD hired Meredith Dressel for Central Management Team Administrator.
- **Jeremy Kaukl, Wisconsin Department of Safety and Professional Services:**
 - Shared that they are currently working on adopting the 2021 building codes from the ADA Guidelines for buildings and facilities covered under Title II.
- **Colleen Larsen, Wisconsin Technical College System:**
 - Colleen Larsen shared that WI Technical College System is working closely with DVR to provide programs for individuals with disabilities. She shared some resource documents outlining what types of services are available.
- **Nicholas Zouski, Wisconsin Department of Natural Resources:**
 - No report provided.
- **Dr. Elizabeth Watson, University of Wisconsin System:**
 - Elizabeth Watson shared that the University of Wisconsin System is partnering with DWD/DVR to support community integrated employment services.
- **Jessica Trudell, Board on Aging and Long-Term Care:**
 - Jessica Trudell shared that the Open Enrollment period for Medicare was October 15-December 7th which is a very busy time for the Medigap Helpline. She stated the Volunteer Ombudsman Program is expanding into Assisted Living homes through a pilot project in 4 counties. Jessica explained that BOALTC continues to support the Medicaid unwinding efforts and those who

lost coverage and are now Medicare eligible are encouraged to call the Medigap Helpline.

- **Jessica also stated that CPD may find the following Legislation to be of interest:**
 - [Assembly Bill 653](#) and [Senate Bill 682](#) relating to surrogate decision making and next of Kin.
 - [Assembly Bill 162](#) and [Senate Bill 155](#) relating to the notification of certain facility closures.

X. CPD Committee Updates

- **Emergency Preparedness, Karen Secor**
 - Karen Secor provided updates on CPD Emergency Preparedness Toolkit distribution and multiple outreach events. Kare shared that the Committee continues to do outreach through presenting online and in-person and planning on having exhibit booths at conferences.
- **Housing, Jeff Fox**
 - The Committee continues to meet bi-monthly and work on strategies and goals linked to the 2022-2024 CPD Work Plan.
- **Employment and Health, Roberto Escamilla II:**
 - The Committee rescheduled their last meeting to February 13, 2024, from 1:00 PM to 2:00 PM.
- **Transportation, Charles Vandenplas**
 - The Committee has invited Kyle Kleist, the Executive Director from the Center for Independent Living for Western WI to talk about the New Freedom Transportation Program, transportation legislation and other volunteer driver programs.
