IV. Public Comment on the State Plan for People with Physical Disabilities 2019-2021, or Issues Affecting People with Physical Disabilities


No public comment was received.

VII. Discuss Draft of Employment and Barriers Survey and Assign Leads

 - The Executive Committee members discussed dispersing the survey to all people with disabilities and not just focusing on Family Care participants.
 - Kathy Johnson and Karen Secor will work collaboratively to draft the Employment and Barriers Survey based updating the 2012 survey questions; and will share the survey outline at the Full Council Meeting on April 22, 2021.

VIII. Discuss Emergency Preparedness Grant and Governor's Committee for People with Disabilities (GCPD) Collaboration

- The Executive Committee discussed \$100,000 in grant funding available through the Office of Preparedness and Emergency Health Care to assist with updating and producing more Emergency Preparedness Toolkit copies and additional documents. These funds need to be expended by June 30, 2021.
 - The Executive Committee discussed updating the pandemic section of the toolkit, incorporating accessible communication documents (visual communications cards, ADRC front desk communication cards, vaccine information, fillable forms and creating an App to utilize to download the toolkit), PowerPoint Presentation and working in conjunction with the Governor's Committee for People with Disabilities (GCPD) on a 'Know your Rights' handout and Cover Letter.
 - Ben Barrett stated that he had discussed GCPD's capacity on collaboration with David Morstad, Chair of GCPD during their Executive Meeting yesterday, and GCPD was willing to assist; however, could not take the lead on the creation of the documents.
