## **V. Public Comment on the State Plan for People with Physical Disabilities, 2019-2021**

- Medicaid Assistance Purchase Program (MAPP)
- Possible need for reviving Community Options Program or a program which allows people with disabilities to earn more income
- ABLE Accounts
- The State Plan Committee discussed actively monitoring the sections of MAPP program that didn't get passed in the expansion legislation, and monitoring how the implementation process for the MAPP expansion.
