

# ENC\_DM\_1.22.7.0 Release Notes

## LTCare Encounter Data Mart Universe

These release notes include changes from release 1.22.5.0, 1.22.6.0, and 1.22.7.0.

### Purpose/Background

### Release 1.22.5.0

The structure of the LTCare Encounter Data Mart will be updated to make objects available to all users that were previously restricted by specific program level access. The objects in the Specific FC Information, Specific CLTS Information, and Specific FCP/SSI Information class folders will be relocated to various existing main class folders. These program specific class folders will be removed from universe.

Another update is that existing SPC Code folders and objects will be hidden and no longer available to users. Reports using SPC Code objects will still run fine; however, any new reports will be required to use Submitted SPC Code objects that were added to the data mart recently. The Submitted SPC Code objects reference the same table and columns as the SPC Code objects.

Other maintenance changes to the LTCare Encounter Data Mart will be made including class folder renaming and arranging folders in alphabetical order. Update the universe structure will be updated so that it's consistent with other universes.

#### Release 1.22.6.0

The derived SPC code logic was updated to identify records with Service Begin Date values greater than 12/31/2299, and assign them default code/description values of ??-BSD/Bad Service Date Value. This will allow for easy identification of records with an unassigned derived SPC code that contain bad service begin date values.

## Release 1.22.7.0

The Derived SPC Category of Service object was added to the Derived SPC sub-class folder which provides the assigned financial category of service correlating to the interChange claims processing assignment for a given derived SPC code.



### New Location of Folders and Objects from Program Specific Folders

- CMO Reason Code object moved to Detail Fact folder.
- Unit or Basis for Measure object moved to Detail Fact folder.
- SPC Code folder and objects hidden. New queries to use Submitted SPC objects located in the SPC folder.

Moved from Specific FCP/SSI Information folder:

- Admit Date folder moved to Detail Dates folder.
- Admitting Diagnosis folder moved to Diagnosis, Drug, and Procedure folder.
- ICD Surgical Procedure Codes folder moved to Diagnosis, Drug, and Procedure folder.
- Patient Status folder moved to Recipient folder.
- Pharmacy folder moved to Claim folder.
- Statement Begin Date folder moved to Detail Dates folder.
- Statement End Date folder moved to Detail Dates folder.

All remaining folders and objects were duplicates.
