This memo states the eligibility categories and standards for the 2025 Social Services Block Grant. It supersedes Numbered Memo 2023-03/Numbered and DSP Memo Series 2016-27.

Policy and Procedure Requirements

The policy and procedure requirements for the Social Services Block Grant are outlined in the SSBG Intended Use Plan located at <u>www.dhs.wisconsin.gov/opib/ssbg.htm</u>. The eligibility categories for the 2025 Social Services Block Grant are:

- Recipients of medical assistance.
- Individuals with income at 75% or below the state's median income. The income eligibility standard for all Social Services Block Grant services has been revised in the Intended Use Plan to reflect the 2024 median income for Wisconsin as published in the Federal Register.
- Recipients of the Wisconsin Shares Child Care Subsidy Program.
- Counties shall continue to provide services funded by the Social Service Block Grant to "qualified aliens," as defined by Section 402(b) of the Personal Responsibility and Work Opportunity Reconciliation Act.

There are no changes to eWiSACWIS documentation associated with this policy or procedure.

Action Summary

- County departments of social and/or human services must establish the following written policies, which must be kept on file and made available to the public:
 - A list of social services provided by the department

 - Procedures to follow for clients who request fair hearings
- Counties will be required to report on services provided and actual expenditures on the Human Services Reporting System (HSRS) through the following reports:
