PURPOSE

The purpose of this memo is to provide guidance to Income Maintenance (IM) and Wisconsin Works (W-2) agencies about treatment of direct financial payments to youth who aged out of foster care between January 27, 2020, and September 30, 2021.

The Consolidated Appropriations Act of 2020 provided funding for the Chafee Program for Successful Transition to Adulthood (Chafee program), including providing direct financial payments from <u>Transition Resource Agencies</u> to youth formerly in foster care. To qualify, youth must have aged out of foster care between January 27, 2020, and September 30, 2021. Youth have the discretion to use these supports as they see fit, including but not limited to meeting basic needs, housing costs, and transportation needs.

These direct financial payments from the Chafee program to youth formerly in foster care are typically disbursed in \$1,000 increments per month for up to six months (no youth shall receive more than \$6,000 total) and are provided by Transition Resource Agencies. Payments may have started as early as June 2021 and are expected to end around March 2022. These payments may be referred to as:

- Direct financial assistance;
- Funding assistance;
- Youth federal COVID stimulus;
- Stimulus payment;
- Stimulus funds;
- Monthly stimulus payment;
- COVID stimulus:
- Stimulus checks for youth who aged out of foster care;
- Special stimulus payment for aging out youth due to COVID;
- Stimulus funding;
- \$6000 payment;
- · Direct stimulus funding;
- Direct payment;
- Direct monthly stimulus payment; or
- Direct financial payment.

POLICY

W-2

For the W-2 program, these payments from the Chafee program are to be disregarded as income for eligibility for W-2 and related programs. This information will be added to the W-2 Policy Manual in Section 3.2.9.1 Disregarded Income.

WISCONSIN SHARES

For Wisconsin Shares, payments from the Chafee program are not counted in the financial eligibility test.

PROCESS

Agency workers should document payments from the Chafee program as disregarded income in case comments in CARES Worker Web (CWW).

WISCONSIN SHARES

Payments from the Chafee program are not required to be entered in CWW, but workers may document receipt of the income in case comments.

RESOURCES
