# **PURPOSE**

This memo announces updated eligibility policies related to universal basic income (UBI) payments and payments from guaranteed income programs.

### **BACKGROUND**

In 2022, the City of Madison launched the Madison Forward Fund, a guaranteed income program that provides monthly payments of \$500 for 155 income-eligible families. These payments are designed to supplement existing assistance programs. FoodShare, BadgerCare Plus, Medicaid, Wisconsin Shares, and Wisconsin Works (W-2) created policies to exclude these payments from counted income for eligibility consideration.

As additional guaranteed income programs are beginning across the state, eligibility policies are changing to clarify how to count UBI and payments from guaranteed income programs in general, not just those from the Madison Forward Fund.

### **POLICY**

The following policies are effective as of June 1, 2024.

## **HEALTH CARE**

Payments from UBI and guaranteed income programs are disregarded as income for BadgerCare Plus and disregarded as income and assets for Medicaid.

### CARETAKER SUPPLEMENT

Payments from UBI and guaranteed income programs are counted as income and assets for Caretaker Supplement.

#### **FOODSHARE**

Payments from UBI and payments from guaranteed income programs are disregarded as income and assets for FoodShare.

#### WISCONSIN SHARES

Payments from UBI and payments from guaranteed income programs are considered gifts and are disregarded income.

Payments from UBI and payments from guaranteed income programs are considered gifts under <u>W-2</u> <u>policy 3.2.8.1</u> and are disregarded income for eligibility determination. These payments do count towards the asset limit.
