FoodShare Updates

There are three FoodShare-specific updates that will be made to the NOD to comply with federal regulations.

Message to Reapply With W-2 or SSI Approval


1. Include a message with a denial of FoodShare or closure of the FoodShare Assistance Group that applicants and members can reapply or contact their local agency if they are approved for W-2 or SSI benefits.

Program	Status	Details
A FoodShare	Your benefits will be ending on February 1, 2024.	See Your FoodShare Benefits to learn more. If you are approved for W-2 or Supplemental Security Income (SSI) in the future, you may be able to get FoodShare benefits. Reapply at <u>access.wi.gov</u> or contact your agency.

Message to Reapply by Completing Required Action

2. Include a message that applicants do not need to reapply if they complete the missing required action (e.g., complete an interview) within 60 days of the application date.

Note: This is currently a part of the NOD issued for missing verifications.



Renewal Month Listed in Second NOD for Expedited FoodShare

3. For expedited FoodShare, the renewal month will be displayed in the change summary when a second NOD is sent after verifications are completed.

Note: This is consistent with NODs for cases that have a change event for their FoodShare benefits (e.g., benefits are approved, benefit amount has increased/decreased, benefits have been denied for some individuals, benefits are reopened).
