The state does not have any mandates on Mobil Integrated Healthcare. This would need to go through legislation before DHS EMS office would be able to approve anything. There is one service that is doing this under a pre-approved pilot program. This has been brought up in legislation. The titles and the laws need to match for this to advance through legislation. The state cannot approve a plan for MIH because it has not gone through legislation. This agenda item can be discussed if MIH does go through legislation at a later date.

10:10 AM	Competency Document Update	West	The NREMT requirements will change Jan. 1, 2017. There are three documents that the Training Centers are following: DHS competency document, CoAEMSP Requirements (ISSR Appendix G - Student Patient Contact Matrix), and NREMT PPCP (Paramedic Psychomotor Competency Portfolio). The training centers are asking to vacate the state requirements for the paramedic level, and adopt the new NREMT PPCP requirements retroactive back to the start of this school year. Motion by Riccardo Colella, second by Steven Zils, that the state adopts the NREMT PPCP and make that retroactive to the beginning of the school year. Motion Carried. Greg would like to see the communications from the state note the requirement for the student to have 10 patient contacts before training is completed.
10:20 AM	Paramedic Curriculum Update	Weir / West	The implementation of the National Registry PPCP has required a change of structure within the state-aligned paramedic program. No additional hours have been added (and there should be no additional financial cost to the students, even though some training centers may see an increase in expenses as a result of the changes), but some of the courses have been modified or changed to accommodate the PPCP requirements within formalized in-class labs and simulations. The sequencing of courses, specifically as it related to student participation in clinical and field experiences, also needed to be updated given the application of the NREMT PPCP.

10:30 AM	Training Permit Process	West	Training Centers are experiencing issues with training center applications getting processed in a timely matter. There are some things that can be done to speed up the process. The state created a training center application through our forms process for elicensing. This will help streamline the approval process. The Licensing Coordinators are touching the same TCTP application 3+ times due to missing information, errors, etc. This causes the process to take longer. Many applications are missing the eligibility certificate (instructor verification form). Missing criminal history documentation is another thing that slows the process. Some students are indicating they have a misdemeanor for a speeding ticket which is not a misdemeanor. Students can upload the CCAP information into their accounts to facilitate the process. A suggestion was made that the questions be changed on the application so the students know what a misdemeanor/felony is. The state has asked that the students submit their applications the first or second day they are in class.
10:40 AM	Distributive Hours for Continuing Education/Refreshers	Zils / West	The state requires National Registry for an initial license. However, it is not a requirement to maintain National Registry when a provider renews. The state created two options for the refresher requirements for online training. One is NCCP compliant. The other is not NCCP compliant but it is approved by the state. Once the forms are signed they can be submitted to the state. The NCCP form can be used for renewing National Registry. The other version can be used for renewing the state license. The state is hoping to send this information to providers by the end of next week. The DHS website has the approved training centers listed.
