Shuruudaha Tallaallada (cirbadaha) la isugu Oggolaanayo Iskuullada Wisconsin
(Required Immunizations (shots) for Admission to Wisconsin Schools)

Ku-socoto Waalidka, Masuulka, ama Qoysaska Carruurta Loo Dhiiba _____ Fasalka _____ Student Immunization Law (Sharciga Tallaalka Ardeyda) waa ardeyda ilaa fasalka 12aad in ay soo qaataan tirada ugu yar oo ah tallaallada laga rabo ka hor inteysan iskuulka bilaaban. Shuruudaha la isaga dhaafi karo waa caafimaadka, diinta ama sababo shakhsiyeed. Ardeyda aan soo qaadan tallaallada laga rabo iskuulka ayaa laga eryi karaa, maxkamad ayaa loo gudbin karaa, iyo/ama maqnaanshaha ayaa lagu cizaabi karaa.
