Why Accreditation?

Public health departments must have the capacity to improve and protect the health of the community. Every person in every community should have access to a basic level of public health services from both the state health department and the local health department. The 10 Essential Public Health Services are the basis by which health departments evaluate their performance and improve practice. The Essential Public Health Services were translated into practice by the national performance standards for public health, which in turn were adapted into the Public Health Accreditation Board (PHAB) standards and measures. Through the external validation by PHAB that an agency has demonstrated implementation of the standards, the community has assurance of access to basic, effective public health services.

Why Foundational Public Health Capabilities?

Implementing Foundational Public Health Capabilities will assist local and tribal health departments in providing essential public health services, improved communication, stakeholder engagement, and efficient stewardship of resources. The lack of public health system infrastructure funding in Wisconsin limits the implementation of Foundational Public Health Capabilities. While every community should be served by an effective and efficient high-functioning public health department, the lack of funding in Wisconsin for system infrastructure has stunted the implementation of the Foundational Public Health Capabilities.

Why Collaborate with Partners to Assess Community Needs?

A community health assessment is needed to provide data to define community health priorities. As a result of the COVID-19 pandemic, many local communities are experiencing exacerbated health

outcomes and health disparities. Community Health Assessments (CHA) provide information for problem and asset identification and policy formulation, implementation, and evaluation. A CHA also helps measure how well a public health system is fulfilling its assurance function.

Why Collaborate with Partners to Address Community Needs?

Local health departments are required to implement a Community Health Improvement Plan (CHIP) at least every five (5) years per Wisconsin Administrative Rule DHS 140, as well as for health departments that are accredited or pursuing accreditation through the PHAB. Through a CHIP, local government can address and provide solutions to a community's most critical health needs.

Program 2: Implement Community-Based Foundational Public Health Interventions

By September 30, 2023, Health Departments will address Foundational Public Health Areas impacting residents by:

Why Community-Based Interventions?

Local and tribal health departments require adaptable funding to support prevention programs impacting a Foundational Public Health Area in their community. Local and tribal health departments have identified Foundational Public Health Area needs in their communities, including environmental health hazards, injury and illness prevention, mental health support, promotion of healthy lifestyles, supporting community coalitions, and AODA education and resources. PHHS Block Grant funds offer an adaptable resource to support prioritized community Foundational Public Health Area needs.
