Governor's Committee for People with Disabilities (GCPD) Annual Report 2022

The GCPD is dedicated to enhancing the health and well-being of Wisconsin citizens who have disabilities. As a Committee of Governor-appointed volunteers with cross-disability council representation (Board for People with Developmental Disabilities, Council on Deaf and Hard of Hearing, Council on Physical Disabilities, Statutory Council on Blindness), GCPD serves to advise the Governor, state agencies, and the state legislature on issues of concern for people who have disabilities.

This report serves as an overview of activity and accomplishments of GCPD during the 2022 calendar year.

GCPD has been appreciative of the collaboration and partnership with the Governor's and Lieutenant Governor's offices over the past year.

Structure and Function

- The full Committee Bi-Monthly meeting schedule established in 2020 was continued through 2022. Full Committee meetings will resume a quarterly meeting basis in the 2023 calendar year. The Executive Committee transitioned from meeting on a weekly basis to meeting month beginning September 2022. The work GCPD is doing requires more research and collaborative meetings to advance GCPD's work plan and related policy issues. Thus, GCPD switched to a monthly meeting basis to allow for assignments to be completed in-between meetings.
- All meetings of the GCPD were held virtually during 2022 and plans to resume hybrid meetings in calendar year 2023. GCPD is grateful for the assistance of the Department of Health Services (DHS) support staff for their assistance with hosting these meetings for GCPD.
- GCPD revised its by-laws including changing the composition of the Governor's Committee
 membership to include a simple majority of people with disabilities (51%); allows Executive
 Committee to find alternative representatives if Council's will not appoint representation to
 ensure all people with disabilities are represented on the Committee; adds registered
 lobbyist disclosure; and changes election cycle for chair and vice chair. It is the hope of
 GCPD that these changes will allow the Committee to recruit members and conduct
 business more effectively.

Activities

- In January 2022, GCPD issued a <u>press release</u> about Margaret Kristan being elected Chair and Rhonda Staats being elected as Vice-Chair of GCPD.
- GCPD worked tireless on a COVID-19 Educational Training Video to capture the
 experiences of people with disabilities accessing health care during the
 pandemic. GCPD's #Access4All video project highlights testimonials from people
 with disabilities and their caregivers about the physical and communication
 barriers experienced in healthcare settings. It is critically important that we listen
 and learn from the experiences and stories of individuals with disabilities, so that
 Wisconsin can continue to be a strong leader in offering the best quality of health
 care to all citizens. The #Access4All videos can be viewed on GCPD's website or
 on GCPD's YouTube channel.
- In March 2022, GCPD issued a letter to Governor Evers asking him to veto Senate Bill 905 and Senate Bill 912 as both bills would negatively impact people with disabilities. Senate Bill 905 proposed changes regarding Medicaid eligibility determinations that would negatively impact people with disabilities by requiring Medicaid eligibility redetermination every six months instead of the current twelve months. Senate Bill 912 would impose penalties on certain "able-bodied" Medicaid members for not accepting a job offer or not agreeing to work more hours, regardless of the nature of the job or how many additional work hours were offered.
- In April 2022, GCPD partnered with the Wisconsin Council on Physical
 Disabilities (CPD) and to create the <u>Emergency Preparedness Communications</u>
 <u>Folder</u>. This folder was designed as a resource for health care providers and
 people with disabilities to address communication and access barriers in health
 care settings.
- GCPD hosted a watch party and listening session for the #Access4All video project on May 19, 2022, Global Accessibility Awareness Day. The event was attended by approximately 80 participants and the <u>Wisconsin State Journal</u> published a story about the Watch Party.
- In September 2022, GCPD did a presentation to Concordia University health alliance students on the Committee, expressions of disability, difficulties in identifying and disclosing a disability, disability etiquette, person-first and identity language, and reasonable accommodations. GCPD received numerous thank you letters from students

and the presentation was so well received that they have asked GCPD to do presentations twice a year for their students.

- In November 2022, GCPD's Transportation Subcommittee made recommendations to the Non-Emergency Medical Transportation program on how to improve forms and processes to better meet the needs of people with disabilities.
- In November 2022, GCPD's Opportunities and Access Subcommittee advanced several
 policy recommendations to the Executive Committee to address accessibility for people
 with disabilities including expanding the Attorney General's Office responsibilities to
 include Civil Rights Enforcement and to have a state government Digital Accessibility
 Coordinator to ensure state government websites and documents are accessible for
 people with disabilities.
- In December 2022, GCPD held officer elections and elected Rhonda Staats as Vice-Chair. Ramsey Lee, Ben Barrett, and John Hartman were also elected as an Executive Committee At-Large Members.

- The vacancies in the at-large positions proves to be challenging due to a
 unique situation within GCPD's own by-laws. The by-laws state that a majority
 of the members must be people with disabilities; in fact, one statement requires
 that 66% have disabilities. At the same time, appointments to the GCPD have
 no term limits. This makes achieving the required level of membership by
 people with disabilities difficult.
- In addition, GCPD recognizes the need to have a more diverse membership
 that better reflects the ethnic and cultural composition of the State's population
 and is exploring strategies to attract people of color and diverse ethnic
 backgrounds tobe appointed to GCPD. GCPD also recognizes the need to
 recruit and attract younger people with disabilities to be appointed to GCPD.
