  - DHS support staff shared that they will be working behind the scenes to translate the #Access4All Videos into Spanish, which may happen after the Watch Party takes place.

  - Margaret Kristan shared that she had received an email from a professor at the Concordia University to request to have a presentation from GCPD in the fall 2022, the full Executive Committee agreed that it would be good for education and outreach.
