#### VI. Discuss Feedback from February 17, 2022, Transportation Advisory **Committee Meeting**

- The Sub-Committee discussed the Transportation Advisory Committee Meeting that was held on February 17, 2022.
- Daniel Idzikowski stated that the major focus of the meeting was the use of Veyo, Wisconsin's Non-Emergency Medical Transportation (NEMT) Broker. Veyo is utilizing both traditional transportation drivers and independent driver programs, like Uber and Lift. This has caused a lot of issues for the traditional providers because the independent drivers have no capability to assist individual with significate disabilities. The provider rate to independent providers is much lower and the traditional driver loses out on the revenue that is going to all the independent drivers due to lower cost; also, unable to increase fleet to meet the demand. Of the 140 independent drivers that Veyo has contract with, 100 are located in Milwaukee. Concerns with lots of competition and lost revenue to traditional drivers.
