 - Rhonda Staats shared she spoke to the Department of Transportation's Non-Driver Advisory Committee's Co-Chair Denise to discuss additional funding for accessible transportation programs. Denise stated that the Non-Driver Advisory Committee's work plan and funding requests are set. Denise shared the most effective way to get more funding for accessible transportation would be to contact Joint Finance Committee members in the Wisconsin State Legislature and tell individual or personal stories related to transportation access issues.
