Wisconsin Vaccines for Children (VFC) Program Newsletter

As a reminder, please check your vaccine inventory and ensure you have sufficient vaccine (a four week inventory is suggested) to meet your needs given ordering blackouts and limited shipping dates.

December

Orders received in WIR after December 11, 2024, may not ship until after January 2, 2025.

There will be limited deliveries beginning December 23, 2024. Regular vaccine deliveries will resume January 3, 2025.

January

There will be no vaccine deliveries on January 13, 2025, due to the Martin Luther King Jr. holiday.

Preparing for the 2025-2026 Flu Vaccine Prebook Season



Mark your calendars for the end of January! Influenza prebook is announced around the third week of January each year, and the prebooking is due about 14 days later.

It is important that you turn in your prebook order so that you have vaccine for the following season. Further instructions on ordering will be included in the January announcement.

Be on the lookout in January for more information regarding how to prebook for influenza vaccine for the 2025-2026 influenza season.

Beyond Use Date (BUD) Guidance

According to CDC, products that are beyond use date (BUD) need to be returned. Follow the return instructions in the <u>VFC Resource Guide</u> for most returns. COVID-19 vaccines that are obtained through the VFC or VFA program that are expired, spoiled, or beyond use date must be returned to McKesson. Follow these <u>instructions</u> and complete the return form.

Please account for all BUD doses as "Doses Spoiled" to remove them from the inventory in WIR.


The only exception is opened Pfizer 2024-2025 6M-4Y vaccine. Opened multidose vials cannot be returned and should be noted as "Wasted" in WIR.

Figure 1: A combined 95% of the 185 survey participants stated they were satisfied or extremely satisfied with the WI VFC program.






VFC Provider Satisfaction Survey Results




Current Respiratory Vaccination Coverage in Wisconsin



Cervical Health Awareness Month

January has been designated as Cervical Health Awareness Month. We encourage your clinic to use January as an opportunity to raise awareness of cervical cancer and the importance of getting vaccinated against the human papilloma virus (HPV), the main cause of cervical cancer.

Cervical cancer is one of the most preventable cancers due to the availability of HPV vaccination and preventative health screenings.

The HPV vaccine is recommended for all children aged 11 or 12, though vaccination can begin as early as age 9 and is recommended through age 26 years for those who were not adequately vaccinated when they were younger.

VFC Open Forum Dates


