- Can take up to 10 business days for uploaded documents to be processed, the app confirms the IM agency has received the documents and shows documents that have been submitted for up to 90 days
- o Future app enhancement may show what the particular program consumer is enrolled in (IRIS, FC, etc)

## Department Updates

**Dana Raue**, Deputy Director, Bureau of Adult Programs and Policy **Amy Chartier**, IRIS Section Chief, Bureau of Adult Programs and Policy

- o Introduced Dana Raue as new deputy director for the Bureau of Adult Programs and Policy
- o <u>Electronic Visit Verification (EVV):</u>
  - Second forum is on Wednesday, April 10 in Milwaukee, geared towards providers and caregivers and will review November forum information, services impacted, and timeline for implementation (2020).
  - SHC codes that are part of EVV will not roll in to IRIS until 2021
  - SDPC services will roll in for everyone when EVV starts.
- o 372 Report: Report is due by June 30, 2019
- Evidenced based report due at end of month (March).
  - Critical Incident reporting requirements have changes. Our system does not easily id what was substantiated.
  - Meeting with APS roundtables, talking about partnering with IRIS agencies and ICAs to keep open communications.
     DHS has drafted a template of an MOU for the ICAs and they will be required to enter into agreement with APS agencies in their areas
- Staffing:
  - Leon Creary Policy Analyst
  - Chris Sell leaving to WISITS team. He has accepted a section chief position in DPH
  - Karina Virrueta contract specialist is now working part-time on finishing documentation and some project plans

# Introduction and 2019-21 Budget Overview

**Jim Jones**, Medicaid Director, Division of Medicaid Services **Curtis Cunningham**, Assistant Administrator, Division of Medicaid Services

- o Jim Jones and Curtis Cunningham introduced themselves
- o Jim plans to meet with IAC on a regular basis
- Proposed budget would have childless adults and parents up to 138% of the Federal Poverty Level (FPL) as potentially eligible for MA

- o There is language in the budget related to IRIS and the extraordinary session
  - Reporting on implementation on a monthly basis, targeting waivers put in the budget 2011 and on
  - There was language put into the budget to solidify IRIS, recognizing it went back prior to 2011
  - There is a definition of self-direction in statute.

# Workgroup Updates

Maureen Ryan, Executive Director, Wisconsin Coalition of Independent Living Center, Inc. Allison McNelly, TMG Sana Kahn, iLIFE

- Accessibility Assessments Maureen Ryan
  - Met 3 times
  - Composed of ICAs, DHS (Shaun Swenson), and Maureen Ryan
  - Mapped out process
  - There is not a lot of guidance currently for FEAs
  - Working to identify gaps
- o Participant-Hired Worker Paperwork Streamlining Sana Kahn
  - Currently meeting every 2 weeks
  - Average application is 20-26 pages, looking to reduce this
  - Making recommendations about needed WISITS updates
  - Once determined what can be done with WISITS, will have better idea how to streamline process
  - Looking at electronic update options so participants have easier access
- IRIS Service Authorizations Allison McNelly
  - PHW hired or let go, how to easily be taken off authorization without having to end the entire authorization
  - Working on allowing more than one worker to be linked to an authorization (already worked on by WISITS)
  - Hoping to start testing in April

### IRIS Waiver Timeline

- o Request for comments on waiver has been sent out
  - This is different than public comment
  - It allows us to hear from public and build their comments into the waiver
- o IRIS Waiver Timeline was discussed
- o IAC should propose waiver changes through public comment
- o Ability of committee to review public suggestion will depend on number of responses received

- Ann Karch mother of IRIS participant
  - FEA issues encountered, happy to hear recommendations from authorizations workgroup.
  - Happy the FEAs have been working to create a unified budget report
  - Would like participants to beta test the report. Can be done around the state so don't all have to be brought together
  - Need to have participants participating in the participant hired worker suggestions (workgroup)
    - Make sure to have people from around the state
  - Update and make more transparent around the committee, new website is great
  - Urge to have meetings at different locations around the state a few times/year
    - Have specific regions as a focus for a meeting, if won't travel, and actively solicit participant input from those areas

#### Consumer ScoreCard

**Gail Propsom**, Section Chief, Quality Management & Initiatives Section **Jasmine Bowen**, Quality Assurance Program Specialist, Quality Management & Initiatives Section

- o Jasmine and Gail walked through PowerPoint
- o Multiple ICAs can have the same star rating based on survey results and other information sourcing
- o Agencies will see their individual results before other info being shared publicly
- There will be some caveats in the data for the first year
- o The ScoreCard will be updated once per year based on the participant survey data
- Expecting trends to be across all ICAs/FEAs when based on policy/programmatic changes
- o Will engage with IAC again to go over measures, rating system, and feedback from pilot
- o DHS will look at providing scripted information for the ADRCs to use when explaining the scorecard to participants

### Self-Direction Data from NCI

**Angela Witt**, Section Chief, Bureau of Fiscal Accountability and Management **Amy Chartier**, IRIS Section Chief, Bureau of Adult Programs and Policy

- Angela walked through PowerPoint presentation
- o DHS contracts with Vital Research (national company) to conduct the survey
  - Those that conduct the survey (interviewers) have some experience with the population and live in the general area
- o Concerns have been expressed that this is only an IDD survey and that is not clear in each slide
  - For future discussions will add a note to slides that they relate to IDD
- o Going forward want to make sure the participant is being heard and their wishes are known
  - Guardians need to be supporting the participant decision making but are not making the participant's decisions
- The NCI-AD survey will cover some of the same questions as the IDD survey. Will be starting to use both surveys
