




What is health?

What is a health equity lens?

A *health equity lens* requires adjusting how we look at and consider individual and population health issues and solutions



What is CLAS?

- Culturally and Linguistically Appropriate Services
- Originally developed in 2000, updated in 2013
- Series of standards to ensure effective and quality care to a diverse population
- Framework for looking at Health Equity

What is CLAS?

- · Governance, Leadership and Workforce
 - Equity around hiring, promotion, policies and training
- Communication and Language Assistance
 - Ensures accessibility of information
- Engagement, Continuous Improvement and Accountability
 - Establishes a culture, promotes integration, encourages evaluation, develops partnerships

What is CLAS?

The CLAS standards:

- Advocate equitable care for all individuals
- Contribute to reduction of health disparities
- Emphasize need for CLAS promoting leadership and policies
- Call for services responsive to individuals needs, health beliefs and communication needs
- Promote respectful, non-discriminatory and accessible environments
