#### **PURPOSE**

The RHFP newsletters are designed to share project updates, resources, and data with RHFP-funded organizations as well as any community partners invested in reproductive health in Wisconsin.

## **Program Update**

In follow-up to a question asked during an RHFP Learning Community (LC) call in July, the RHFP program received the following information from the Division of Health Services (DHS) Office of Legal Counsel:

Neither state nor federal law prohibits referrals to Planned Parenthood for family planning care when no payments would be made. While the new rules promulgated as part of the Title X program limit the ability of recipients to refer for, or provide information about, abortion services, it does not prohibit referrals for family planning care.

However, no women's health or family planning funds can be distributed to Planned Parenthood. Both federal and state law prevent those payments. Funding that is unrelated to women's health or family planning may be possible; in those situations, please consult with DHS's Office of Legal Counsel.

Updated RHFP program clinical protocols are well on their way to being released. They will be given to the Department of Health Services Office of Legal Counsel (OLC) for review and approval. Once OLC approves the protocols, the quality improvement committee will review for acceptance and the advisory committee will give the final approval before statewide release for implementation into practice.

# Clinic Spotlight continued

Summary statements from the learning community call poll questions:

- 53% of participants say that COVID has caused a decrease in clients seen in the past month
- 27% say that COVID has caused an increase in clients seen in the past month
- 20% say that COVID has not had an impact on the number of clients seen in the past month
- 93% of participants say that the learning community calls are beneficial
- 13% say that there are services that can't be provided due to COVID in the past month (IUD insertion and STD testing)
- 60% say that expansion efforts have stalled or slowed down during the pandemic






### Data in Action

# How has the pandemic impacted the number of patients seen?

Title X Patient Counts by Month, 2019-2020



<sup>\*</sup> Does not include Title X clinics missing monthly counts for January-June 2019 or January-June 2020. Included Title X clinics: Ashland, Barron, Chippewa, Clark, Eau Claire, Iron, Newcap, Oneida, Pepin, Pierce, Polk, Price, Rusk, Sawyer, St. Croix, and Southwestern Wisconsin Community Action Program (SWCAP). There are many reasons for missing monthly counts, including electronic health record (EHR) limitations and COVID-19, and additional clinics will be added as their data are received.

#### Data Highlights:

- Title X clinics have seen almost 40% fewer patients in 2020 compared to 2019.
- The **biggest decrease** in patients seen (-27%) occurred between March and April 2020, which is also when the Safer at Home Order was implemented.
- However, between May and June 2020 there was a large increase in patients seen (+44%).
   We know clinic staff are working hard to make this happen and hope this trend continues into Q3 and Q4.
