The sum of the health departments do not add up to the state total because children may have received separate blood tests while living in different health department jurisdictions.

B) All counts are unduplicated within each health department jurisdiction.

C) Tested 5 µg/dL or above: Any child with a blood lead level of 5 µg/dL or more. Both capillary and venous results are included. However, if a child has a venous result <5 µg/dL within 90 days of a capillary result ≥5 µg/dL, they are not counted as lead poisoned, the information from the venous test is used instead.

D) Percent 5 µg/dL or above is the total tested 5 mcg/dL or above divided by the total number tested.
