Tsoom fwv txoj cai lij choj yuav tsum kom txhua lub xeev siv EVV rau kev saib xyuas mob nkeeg rau tus kheej uas raug pab nyiaj los ntawm Medicaid.

EVV yuav tsis pib ua ntej xyoo 2020 thiab yuav txav mus rau zeeg sijhawm tom ntej.

Cov neeg ua haujlwm tuaj yeem siv qhov twj siv app lub xov tooj ntawm tes, ib lub xov tooj hauv tsev, los sis ib lub chaw EVV digital ua qhov no tau. Nce raws li qhov yuav tswj xyuas li cas, cov neeg uas tau txais kev saib xyuas yuav tsis tau txais daim ntawv ceeb toom EVV li lawm.

Wisconsin Kev Cog Lus

Los ntawm cov rooj sib tham, pawg kws pab tswv yim, thiab lwm cov ntaub ntawv, peb yuav qhia xov xwm tshiab rau koj txog qhov kev pab no. Peb ntaus nqi siab rau koj cov lus qhuab qhia thiab zoo siab txais tos koj cov lus xam pom thiab cov nqe lus nug.

Peb yuav ua haujlwm txog:

- Muab kev tuav tswj ntau yam pab txhawb rau hauv lub zos.
- pab txhawb txog kev xaiv kws kuaj mob.
- Saib xyuas feem kev xaiv ntawm tus neeg ua haujlwm.
- Ua kom muab kev saib xyuas raws li qhov xav tau.
- Ua kom cov ntaub ntawv raug ceev zoo thiab ua raws li txoj cai ntawm Txoj Cai Is Saws Las Saib Xyuas Mob Nkeeg (Health Insurance Portability and Accountability Act-HIPAA).

Lub Tsev Haujlwm Saib Xyuas Kev Noj Qab Haus Huv (Department of Health Services-DHS), DXC Technology, thiab Sandata tab tom ua haujlwm ua ke kom tau raws li cov cai kav ntawm EVV thiab yuav muab kev cob qhia rau cov neeg uas muaj feem xyuam koom nrog. Muaj ntau cov

ntaub ntawv hais txog cov hnub cob qhia thiab cov txheej txheem yuav tau ua raws.

EVV siv technology teev cov ntaub ntawv tseg:

- Leej twg yog cov tau muab hom kev saib xyuas mob nkeeg
- Leej twg yog cov tau txais kev saib xyuas mob nkeeg
- Yuav pib mus ntsib rau thaum twg thiab tag rau thaum twg thiab yuav mus ntsib rau qhov chaw twg

EVV tsis yog ib qho hloov rau kev saib xyuas mob nkeeg rau cov neeg.
