

XAAQOQAHADUU MACMIILKA

Markaad hesho nooc uun kamid ah adeegyada xanuunka dhimirka, khamriga, isticmaalka maandootiyaasha, ama naafada dhanka kobaca, waxaad leedahay xaaquuqaha soosoda sida kucad sharciga Wisconsin Statute sec. 51.61 (1) iyo DHS 94, Wisconsin Administrative Code:

XAAQOQAHADUU SHAQSIGA

- Waxaa qasab ah in laguula dhaqmo qaab ay kudheehan tahay sharaf iyo qadarin, kaasoo kacaagan xadgudubka dhinacyada hadalka, jirka, dareenka, ama galmada ah.
- Waxaad xaq uleedahay in shaqaaluhu kagaaraan go'aan cadaalad ah oo macquul ah daaweyntaada iyo daryeelkaaga.
- Madhici karto in cadaalad daro lagugula dhaqmo sababo laxariira isirkaaga, wadankaad kasoo jeedo, jinsigaaga, da'dada, diintaada, naafadaada, ama dookhaaga galmada.
- Laguuma dirsan karo shaqo marka laga reebo hawlaха gurigga. Haddii aad aqabsho inaad samayso shaqo kale, waxaa qasab ah in mushaar lagugu siiyo.
- Waxaad gaari kartaa go'aano kuugaar ah oo laxariira waxyabaha sida inaad guursato, codeysyo, iyo doonista shaqada, haddii aad kawayn tahay da'da 18, aana sharci ahaan laguu aqoonsan qof aan masuuliyad qaadi karin.
- Waxaad u adeegsan kartaa lacagtaada sidaad rabto.
- Cidna kaama duubi karto muuqaal, cajalad, ama sawir ilaa inaad ufasaxdo maahee.

DAAWEYNTA IYO XAAQOQAHADUU LAXARIIRA

- Waxaa qasab ah in lagu siiyo daawayn degdeg ah oo kugu filan, baxnaanin, iyo adeegyada waxbarashada ee kugu haboon.
- Waxaa qasab ah in laguu ogolaado qorshaynta daawayntaada iyo daryeelkga.
- Waxaa qasab ah in lagaaga warbixiyo daawayntaada iyo daryeelkaaga, ayna kujiraan noocyada badalka ah ee aad heli karto

dhibaatooyinka kadhalan kara daawada, ayna kujiraan daawooyinku.

- Majirto daawayn ama daawooyin lagu siin karo adoon bixin ogolaansho qoran, oo faahfaahsan, **ilaa in** loogu baahda maahee **xaalad degdeg ah** si looga hortago dhibaato gacan qaad ah oo aad naftaada ama dadka kale ugaysan karto, ama **maxkamad amarto**. [Hase yeeshi, haddii aad leedahay qof masuul kaa ah, qofkaas masuulka kaa ah ayaa bixin kara ogolaanshaha daawada ama daawooyinka lagu siinaayo asagoo wakiil kaa ah.]
- Laguma siin karo daawooyin aan muhiim ahayn ama xad dhaaf ah.
- Laguma galin karo daawaynta korontada ama nooc kale oo daawaynta qaliinka ah sida qaliinka dhimirka ama cilmi baaris tijaabo ah adoon bixin ogolaansho qoran.
- Waxaa qasab ah in qoraal ahaan laguugu sheego qarashaad kasta oo kubaxaaya daawaynta ama daryeelkaaga oo ay tahay in adigga ama qoyskaagu dhiibaan.
- Waa in laguu daaweyyaa qaab ugu xadidan iyo goobta kuhaboon si loogaaro ujeedada lagusoo galiyay barnaamijka, ayadoo laraacaayo xeebdaabyada qarashaadka laheli karo.

QARSOODIGA DIIWAANKA IYO GALITAANKIISA

Sida kucad sharciga Wisconsin Statute sec. 51.30 iyo DHS 92, Wisconsin Administrative Code:

- Macluumaadka daawayntaada waa inuu ahaa mid qarsoon (sir ah), ilaa in sharcigu fasaxo faafintiisa maahee.
- Diiwaankaaga lama faafin karo adoon ogolaansho bixin, ilaa in sharcigu sifo qaas ah u ogolaado maahee.
- Waxaad codsan kartaa inaad aragto diiwaanadaada. Waxaa qasab ah in lagu tusiyo diiwaano kasta oo laxariira caafimaadkaaga jirka ama daawooyinkaaga. Shaqaalaha ayaayarayn kara inta jeer ee aad arki karto diiwaanadaada kale ee daawaynta inta adeegyadu kuusocdaan. Waxaa qasab ah in laguu sharxo sababaha xadidadaas noocas ah

loosameeyay. Waxaad uga hor imaan kartaa sababaha noocas ah hanaanka cabashada.

- Kadib marka lagaa saaro daryeelka, waxaad codsan kartaa diiwaankaaga dawaynta oo buuxa haddii aad sidaas codsato.
- Haddiinaad aaminsantahay in wax kaqaldan yihii diiwaanadaada, waxaad kadagaalami kartaa sixitaankeeda. Hadaan shaqaaluhu badali karin qaybta diiwaankaaga kamid ah ee aad kahortimid, waxaad gudbin kartaa cabasho iyo/ama waxaad galin kartaa noocaad rabto ee macluumaad ah.
- Nuql kamid ah sec. 51.30, Wis. Stats., iyo/ama DHS 92, Wisconsin Administrative Code, ayaad heli kartaa markaad codsato.

HANAANKA CABASHADA IYO XAAQOQDA HELITAANKA MAXKAMADA

- Kahor intaan daawayntu bilaaban, adeeg bixiyuhu waa inuu kuusheegaa xaaquuqdaada iyo sida aad u adeegsanayso hanaanka cabasho gudbinta. Nuql kamid ah Hanaanka Cabashada (Grievance Procedure) ayaah laheli karaa markii lacodsado.
- Haddii aad dareemayso in lagugu xadgudubay, waxaad gudbin kartaa cabasho.
- Laguuguma hanjabi karo ama laguuma ganaaxi karo qaab kasta oo aad kusoo bandhigo cabashooyinka si dadbadan adoo lahadlay shaqaalaha, ama qaab toos ah ood cabasho kugudbisay.
- Waxaad awoodaa, halkii aad kaqori lahayd cabashada ama markaad dhamayso hanaanka cabashada, ama xili kasta inta lagu jiro waqtigaas, inaad doorato inaad cabashada ugayso maxkamad si aad uga dacwooto dhib laguu gaystay ama kiiis kale oo maxkamadeed hadaad aamin santahay in xaaquuqdaada lagu tuntay.

HEERARKA XALINTA CABASHADA

Go'aan aan toos Ahayn (Ikhtiyaari ah)
Waxaa lagugula talinayaa inaad marka koowaad lahadasho shaqlaaha aadna kala hadasho

walaacyada aad qabto. Hase yeeshi, qasab maaha inaad arintaan samayso kahor intaadan gudbin cabasho toos ah oo aad udirtu adeeg bixiyahaaga.

Baaritaanka Cabashada—Su'aal waydiinta caadiga ah

- Haddii aad doonayso inaad cabasho gudbiso, waa inaad gudbisaa 45 maalin gudhood laga bilaabo xiligaad ogaatay dhibaataada. Maareeyaha barnaamijka ayaa axsaan kuusamayn kara oo kusiin kara waqtii kabadan 45-maal mood.
- Khabirka Xaqqoqda Macmiilka (Client Rights Specialist) (CRS) ayaa baaritaan kusamaynaaya cabashadaada iskuna dayaaya inuu xal kagaaro.
- Ilaa in cabashada xal looga gaaro qaab dadban maahee, CRS wuxuu qorayaa warbixin 30 maalin gudhood laga bilaabo maalinta aad codsatay cabashada tooska ah. Waxaa lagu siinayaa nuql kamid ah warbixinta.
- Haddii adigga iyo maareeyaha barnaamijku kuheshiisaan warbixinta CRS-ka iyo soojeedinadiisa, soojeedinada ayaah lafulinayaay gudaha mudada lagu heshiiyay.
- Waxaad gudbin kartaa cabashooyin badan intaad awoodo. Hase yeeshi, CRS wuxuu kaliya kashaqayn karaa hal cabasho markiiba. CRS wuxuu kaacodsan karaa inuu ukala hormariyo siday ukala muhimsan yihii.

Go'aanka Maareeyaha Barnaamijka

Haddii aad cabashada lagu xalin warbixinta CRS-ka, maareeyaha barnaamijka ama wakiilkiisu waa inuu diyaarshaa go'aan qoraal ah 10 maalin gudhood lag bilaabo markay soo baxday warbixinta CRS-ka. Waxaa lagu siin doonaa nuql kamid ah go'aanka.

Dulmarka Heerka Maxkamada

- Haddii aad adeegyo kaqaadato wakaalada degmada, ama wakaalad gaar looleeyaha ayadoo wakaalada degmadu bixiso qarashka adeegyadaas, waxaad racfaan kaqaadan kartaa maareeyaha barnaamijka adoo udiraaya Agaasimaha Wakaalada Degmada (County Agency Director). Waxaa qasab ah inaad

racfaan gudbiso 14 maalin gudahood laga bilaabo maalinta aad hesho go'aanka maareeyaha barnamijka. Waxaad kacodsan kartaa maareeyaha barnamijka inuu cabashadaada gudbiyo ama adigii toos udiri kara.

- Agaasimaha Wakaalada Degmada (County Agency Director) waa inuu soosaaraa go'aankiisa oo qoraal ah 30 maalin gudahood kadib marka codsiga racfaankaan ladiray.

Baaraha Cabashada Gobalka (State Grievance Examiner)

- Haddii cabashadaada ay gaarto degmada si a ubaaraan aadna kuqanci waydo go'aanka, waxaad racfaan udirsan kartaa Baaraha Cabashada Gobalka (State Grievance Examiner).
- Haddii adeegyada aad ka bixineyo hay'ad gaar ah, waxaad racfaan ka qaadan kartaa maareeyaha barnamijka si toos ah Baaraha Cabashada Gobalka (State Grievance Examiner).
- Waa inaad racfaanka ugudbisaa Baaraha Cabashada Gobalka (State Grievance Examiner) 14 maalin gudahood kadib markuu kusoo gaaro go'aanka laxariira racfaankii hore.
