#### SeniorCare

**Program Overview and Statistics** 

### SeniorCare Overview

- SeniorCare provides a comprehensive prescription drug benefit for Wisconsin residents who are age 65 and older with income at or below 200 percent of the federal poverty level (FPL) and are not otherwise receiving full Medicaid benefits.
- SeniorCare has been in operation since 2002.

## SeniorCare Objectives

- Keeping Wisconsin seniors healthy by providing a necessary prescription drug benefit with low administrative burden and a high level of member satisfaction.
- Helping protect the finances of low-income Wisconsin seniors by controlling prescription drug costs and reducing financial barriers to obtaining needed medications.

## SeniorCare Objectives (cont.)

Reducing the rate of increase in medical services provided to this population such as hospital, emergency department, and nursing facility services.

## Two-Part Program

- Wisconsin statute requires the Department of Health Services (DHS) to operate a SeniorCare program and to request a waiver from the Centers for Medicare and Medicaid Services (CMS).
- The differences between the two parts of the program include difference in funding, governing agencies, and income limit thresholds.

## Two-Part Program (cont.)

- Levels 1 and 2a are the waiver program portion of SeniorCare.
- The waiver portion of SeniorCare is:
  - For individuals with income up to 200 percent of the FPL.
  - Governed by state and federal rules.
  - Funded by state and federal funds.

## Two-Part Program (cont.)

- Levels 2b and 3 are the non-waiver, also known as the State Pharmaceutical Assistance Program (SPAP) portion, of SeniorCare.
- The SPAP portion of SeniorCare is:
  - For individuals with income over 200 percent of the FPL.
  - Funded by General Purpose Revenue (GPR).
  - Not federally funded.

#### Enrollment


- Waiver program enrollment is about 41,000 people per month.
- Non-waiver (state-only) enrollment is about 56,000 people per month.

#### SeniorCare Waiver Amendment

**Process and Proposed Coverage** 

#### **Current Waiver**

- The Division of Medicaid Services (DMS) submitted an application to extend the SeniorCare waiver on June 15, 2018.
- CMS approved the waiver application on April 12, 2019, for an unprecedented 10-year extension.
- The SeniorCare waiver will expire on December 31, 2028.

#### Waiver Amendment

- DMS is required to submit any proposed changes to the SeniorCare waiver to CMS.
  - The change must be submitted as an amendment to the waiver.
  - DMS must receive approval of the amendment before implementing any changes to the benefit.
- DMS plans to submit an amendment to the SeniorCare waiver to CMS in November 2020.

#### Waiver Amendment Process

#### Steps in the process include:

- Tribal consultation prior to amendment submission.
- Notice to the Wisconsin Legislature.
- A hearing to offer the public an opportunity to learn more about the waiver amendment and comment on it.
- A 14-day public comment period.

## Vaccine Coverage

- 2019 Wisconsin Act 185 was enacted on April 16, 2020.
- Act 185 requires SeniorCare to cover vaccines that are recommended for administration to adults by the Centers for Disease Control and Prevention.
- A waiver amendment is required to include vaccine coverage under the SeniorCare program.

## Vaccine Coverage (cont.)

#### SeniorCare plans to cover the following vaccines:

- Influenza
- Pneumococcal
- Diphtheria
- Tetanus
- Pertussis

- Shingles
- Meningococcal
- Hepatitis A and B
- Varicella Zoster (chicken pox)

## Vaccine Coverage (cont.)

- Members will be able to receive vaccines through their local pharmacy from a pharmacist trained to give vaccinations.
  - A pharmacist may administer any vaccine listed in the current immunization schedules recommended by the federal advisory committee on immunization practices and published by the Centers for Disease Control and Prevention.
  - No prescription is required.
- SeniorCare is the payer of last resort and will coordinate benefits with Medicare Part D.

## Vaccine Coverage (cont.)

There will be no out-of-pocket expenses.
