What is NEMT?

- A public transportation and shared ride service that provides Medicaid and BadgerCare Plus members rides to covered services.
- Rides can include public transportation, specialized medical vehicles, or other types of vehicles depending on medical and transportation need.

History of NEMT Management Model

- NEMT management model approved in 2010 with bipartisan support
- DHS implemented first transportation manager, LogistiCare, July 1, 2011
- SE HMO members September 1, 2012
- Statewide contract with MTM Inc. August 1, 2013
- New RFP posted 2019



DHS NEMT Goals

- Ensure that Wisconsin Medicaid and BadgerCare Plus members have reasonable and timely access to transportation to covered services
- Ensure that Medicaid and BadgerCare Plus members use the most appropriate and economical mode of transportation



DHS NEMT Goals (cont.)

- Eliminate waste, fraud, and abuse in Medicaid and BadgerCare Plus transportation
- Increase overall efficiency within the Medicaid and BadgerCare Plus non-emergency medical transportation program
- Collect and report transportation data to enable the Department to more closely manage this benefit



Who is Eligible for NEMT?

- Wisconsin Medicaid or BadgerCare Plus members in the following plans who have no other way to get to their appointment are eligible for NEMT:
 - Family Planning Only Services
 - BadgerCare Plus Standard Plan
 - BadgerCare Plus Express Enrollment
 - Tuberculosis-Related Services Only Benefit.
 - Wisconsin Medicaid (including IRIS)



Members Excluded from the NEMT Manager

- Members in a nursing home that have not elected Hospice
- Members enrolled in Family Care, Family Care Partnership, or the Program of All-Inclusive Care for the Elderly (PACE)



Miscellaneous Policies

- Allowed Escorts
 - A medically required escort, such as a family member or friend
 - A parent/caregiver if the member is a minor
- Meals and Lodging
 - Meals and lodging are covered if a member's trip meets certain criteria



NEMT Manager

- Medical Transportation Management, Inc. (MTM) is the Wisconsin Medicaid and BadgerCare Plus NEMT manager.
- MTM schedules and pays for rides to covered Medicaid and BadgerCare Plus appointments if members have no other way to get a ride.



Scheduling NEMT

- Members or their representative call the 800 number for the NEMT manager to request transportation. Online option available.
- Rides for routine appointments must be scheduled at least two business days in advance.
- Rides to urgent appointments will be provided in three hours or less.



Scheduling NEMT (cont.)

- Rides for regularly scheduled appointments can be scheduled up to three to six months at a time.
- If a return ride has not been scheduled in advance of the trip, members or their representative can call the "Where's My Ride" number, and a ride will be available within one hour.



Complaints

WHY WOULD I FILE A COMPLAINT?

- Incorrect trip times or dates
- MTM, Inc. did not secure transportation
- Ride is late or fails to show up
- Vehicle quality and/or appearance
